The Application for Military Service Credit allows a **currently employed** member who was a **contributing member on December 31, 2003**, to purchase up to 60 months (five years) of active duty military service credit at \$15.00 for each month.

**Note:** For members who wish to establish time-credit only for military service, see Form TMRS-34A.

### Conditions for Use of this Form

- In most cases, you will use this form to establish Military Service Credit for military service performed before you became a city employee. For military service performed during your city employment, see the Military Service Credit under USERRA section below.
- Your employing city must have authorized by ordinance the purchase of Military Service Credit prior to January 1, 2004.
- You must have at least five years of TMRS service (prior or current) credit in cities that have authorized Military Service Credit.
- Your military service must have been terminated by release from active duty under conditions other than dishonorable.
- You must file this application and submit a copy of your discharge papers (DD214 or equivalent).
- You must be employed by the city authorizing the purchase and must have been a contributing member on December 31, 2003.
- If you choose to purchase less than the full amount of Military Service Credit authorized by law, you may not purchase any additional Military Service Credit at a future date.
- You cannot receive TMRS credit for military service already credited with another statewide retirement system.
- You cannot receive TMRS credit for military service for which you are receiving (or are eligible to receive) federal retirement payments based on 20 years or more of active military service.

### Military Service Credit Notes

- Military Service Credit is not included in the calculation of Updated Service Credit.
- Deposits to establish Military Service Credit are treated as after-tax contributions.
- If you leave city employment and choose a refund of your TMRS member deposits and interest, your Military Service Credit deposits will be refunded to you.

### Military Service Credit Under USERRA

If your city service was interrupted to perform active duty military service (either voluntary or involuntary), you may be eligible to receive credit for active military duty under the provisions of the federal Uniformed Services Employment and Re-employment Rights Act (38 USC Section 4301, et.seq.).
